This agreement is based on a review of the **Precision Machining** program at Sentinel Career and Technology Center in Tiffin, Ohio and a joint discussion among the faculty and administration which included an evaluation of the applicable course content and instructional methodologies. This agreement is effective beginning with the 2016 graduates and shall remain in effect until it is amended or terminated.

Students participating in the Precision Machining program at Sentinel Career and Technology Center will be eligible to receive academic credit upon completion of the specific credit eligibility requirements. Refer to Terra State Community College's (TSCC) Articulated and Transcripted Course Credit Agreement Guidelines for College and Career Readiness and Adult Education Programs for terms and conditions. Academic credit received may apply to a Certificate and/or an Associate Degree from TSCC or transferred to another institution of higher learning. Acceptance of credit by another institution is at the sole discretion of that institution. It is the student's responsibility to confirm whether credits earned at TSCC will be accepted by another institution.
