BACHELOR OF SCIENCE IN THE NURSING COMPLETION PROGRAM

ARTICULATION AGREEMENT BETWEEN: MERCY COLLEGE OF OHIO AND TERRA STATE COMMUNITY COLLEGE

It is mutually agreed by Mercy College of Ohio and Terra State Community College that Mercy College will accept a student's transfer credits from Terra State Community College's Associate Degree in Nursing toward the Bachelor of Science in the Nursing Completion Program.

This transfer of credit will apply only to holders of the Associate Degree in Nursing. Mercy College of Ohio will transfer acceptable semester hours to the Bachelor of Science in Nursing to meet College and Program requirements.

The transfer of credits to the Bachelor of Science in Nursing is the responsibility of the Mercy College Office of the Registrar, Associate Dean of Nursing and the Chair of Nursing. Graduates who have earned an Associate degree in Nursing from Terra State Community College may be eligible for admission into the Bachelor of Science in Nursing Program at Mercy College of Ohio. Graduates who do not meet the published admission criteria that are in effect at the time of application may be (either provisionally or conditionally) admitted after their official transcripts have been reviewed by the Nursing Admission and Progression Committee at Mercy College of Ohio. Graduates from Terra State Community College seeking admission to the Bachelor of Science in Nursing Program at Mercy College of Ohio must supply official transcripts from all institutions they have attended, including high school. Applicants must also complete the Mercy College application. All application fees will be waived for Terra State Community College students applying to the Bachelor of Science in Nursing Program.

Terra State Community College will retain full responsibility for the educational program of its students.

This agreement may be terminated by either party upon written notice, six months prior to the effective date of termination. BSN students who have matriculated from Terra State Community College and who are in process at Mercy College will remain in the Mercy College BSN Program through graduation.

This articulation agreement between Terra State Community College and Mercy College of Ohio will be in effect for five years (unless terminated as stated above) from the latest date signed below. Renewal of this agreement may be signed up to six months prior to the expiration of the current agreement.

ARTICULATION AGREEMENT BETWEEN: MERCY COLLEGE OF OHIO AND TERRA COMMUNITY COLLEGE

It is mutually agreed by Mercy College of Ohio and Terra Community College that Mercy College will accept a student's transfer credits from Terra Community College's Associate Degree of Technical Study, Health Care Administrations toward the Bachelor of Science in Health Care Administration Degree Completion Program.

This transfer of credit will apply only to holders of the Associate Degree of Technical Study, Health Care Administration. Mercy College of Ohio will transfer acceptable semester hours to the Bachelor of Science in Health Care Administration Program to meet College and Program requirements.

The transfer of credits to the Bachelor of Science in Health Care Administration Program is the responsibility of the Mercy College Office of the Registrar and the Chair of the Health Care Administration Program. Graduates who have earned an Associate Degree of (Technical Study, Health Care Administration from Terra Community College, with a minimum GPA of 2.3 will eligible for admission to the Bachelor of Science in Health Care Administration at Mercy College of Ohio. Graduates who do not meet the above criteria may be (either provisionally or conditionally) admitted after their official transcripts have been reviewed by the Admission, Progression and Graduation Committee at Mercy College of Ohio. Graduates from Terra Community College seeking admission to the Bachelor of Science in Health Care Administration Program at Mercy College of Ohio must supply official transcripts from all institutions they have attended, including high school. Applicants must also complete the Mercy College application. All application fees will be waived for Terra Community College students applying to the Bachelor of Science in Health Care Administration Program.

Terra Community College will retain full responsibility for the educational program of its students. Furthermore, Terra Community College will inform Mercy College of Ohio of changes in the curriculum or personnel in the Associate Degree of Technical Study, Health Care Administration. Failure to do so will prevent the articulation of transfer credit for the Bachelor of Science in Health Care Administration Degree Completion Program at Mercy College of Ohio.

This agreement may be terminated by either party upon written notice, six months prior to the effective date of termination. This articulation agreement between Terra Community College and Mercy College of Ohio will be in effect for five years (unless terminated as stated above) from the latest date signed below. Renewal of this agreement may be signed up to six months prior to the expiration of the current agreement. Termination of the agreement will not affect students who have already been admitted to the program.
